- c. Deputy Mayor Piccini comments on the Comcast/other Cable Franchises. These agreements are not exclusive and we welcome alternate providers.
- d. Mayor Schoenig:
 - i. Police vehicle grant received (\$25,000).
 - ii. Stop sign for Phillips Lane at Putnam Terrace will be reviewed in the Spring.
 - iii. Police Department is online with TRACS which will eliminate paper tickets and speed up the process of State VTL violations.

10) New Business

a. Mayor Schoenig advises that the DPW snow budget is under severe stress because of the large and frequent storms of the last 3 to 4 weeks. The Board of Trustees is 100% behind the DPW Superintendent and his crew and commend them for doing a terrific job of keeping the streets and walks in good condition during these severe storms. The Board will support the expenses as necessary to ensure continued excellence.

11) Public Comment

- a. Tyler Murello asks what happened to the Police Vehicle Blazer; vehicle sold for \$2,500. Also sold the K-9 cage for \$200. The 1999 Crown Victoria still needs to be sold. Tyler also asked about overtime for Police officers; the officers earn overtime (1.5 times) the rate for 6 holidays New Years, Memorial Day, July 4th, Labor Day, Thanksgiving, and Christmas.
